Admissions Criteria

1. Completion of ALL Foundations courses with a grade of "C" or higher
2. Completion of PSYC 201 with a grade of "C" or higher
3. Earn a grade of "C" or higher in General Education, Pre-Admission, and Professional Education courses
4. Combined GPA (all post-secondary work) or 2.5 or higher
5. No more than 5 non-program classes remaining
 - a. Non-Program courses include all the courses listed on Page 1
 - b. It is highly recommended to start the program with only two non-program courses remaining. Summer courses may be required if starting the program with more courses.
6. Completion of 42 semester hours

Students should submit their application online to their program of choice even if they are in the process of meeting declaration requirements or eligibility requirements.
