- Employment Verification

In order to receive MTR, I understand and agree to the following conditions :

1. I must be Active Duty military, currently in Drilling Status in the Reserves or National Guard, or Department of Defense (DoD) Civilian Personnel.
2. I must complete an application for all unauthorized semesters.
3. I understand that a completed application WITH proof of qualifying status is due prior to start of term.
4. I must have one day of qualifying status in a semester to be eligible for that semester.
5. I must notify Military and Veteran Services if my qualifying status changes.
6. I understand that MTR is subject to availability.
7. I understand that Illinois Veterans Grant or Illinois National Guard Grant cannot be used in the same enrollment period as the MTR.

The MTR and proof of Military Service or DoD civilian employment must be submitted to Military and Veteran Service in person or by email.
